RELEASE FROM LIABILITY FORM

Release Of Liability And Indemnification Clause

I, as either the Participant and/or as the parent (s) and/or legal guardian (s) of said Participant, agree that in the event that the Participant suffers an illness, injury or injuries while participating in any BBYT sponsored production, event and/or program, the parent (s), legal guardian (s) and/or Participant shall be solely and fully responsible for any and all medical or injury-related treatment and/or expenses. By signing the Agreement, I, either for myself as the Participant and/or as the parent (s) and/or legal guardian (s), hereby agree to defend, indemnify and hold harmless BBYT and/or its assignees, its officers, board of directors, agents, employees, volunteers, staff, independent contractors, subcontractors and/or their assignees from any and all claims, actions, expenses, costs, obligations, liabilities and/or damages (or any other element of damages), known or unknown, resulting from or arising out of the rendering of any and all first aid, if any, and/or resulting from any illness, injury, injuries, and/or death of the Participant occurring at any time during and/or related to the participation in any BBYT sponsored production, event and/or program.

Workman's Compensation Clause

You are hereby advised that Broadway Bound Youth Theatre Foundation does not carry Workman's Compensation Insurance for participants or volunteers. If you or your child/children should suffer an injury while participating in a BBYT production process, you will be personally responsible for your medical or injury related expenses.

Further Limitation Of Liability And/Or Damages

BBYT is not responsible for any reason for any act or omission (whether said act or omission is intentional, negligent and/or for reasons beyond the control of BBYT) of BBYT and/or its assignees, its officers, board of directors, agents, invitees, employees, volunteers, staff, independent contractors, technical crews, subcontractors and/or their assignees and which results in damages, costs and/or expenses to and/or on behalf of the Participant and/or the Participant's parent (s) and/or legal guardian (s). In the event BBYT is found liable for the injuries and/or damages of the Participant, and/or of the parent (s) and/or legal guardian (s) of the Participant, the limit of damages shall not exceed under any circumstances the amount of tuition paid to BBYT on behalf of the Participant. Also, BBYT is not responsible for any lost or stolen item of personal property of the Participant while said property is at any BBYT sponsored production, event and/or program.

Indemnification Clause

"I hereby agree to release, defend, indemnify and hold harmless Broadway Bound Youth Theatre Foundation, its officers, directors, staff, volunteers, agents, landlords, invitees, employees, contactors and independent contractors from any and all liability arising from, or related to, my child's/children's or my participation in BBYT activities associated with BBYT's theatrical productions.
